

AFFIDAVIT

1. I _____ F/M/G of _____ student of class _____ admitted in Army Burn Hall College for Boys, Abbottabad, have read all the provisions/rules and regulations in the prospectus of Army Burn Hall College for Boys, Abbottabad, and I, hereby, solemnly affirm to abide by them, and also to abide by any other rules which may be framed by the College authorities in future. Additionally,

- a. I accept the seat offered to my son / ward and undertake to abide by all rules, regulations and procedure of Army Burn Hall College for Boys, Abbottabad. I also give an undertaking that, in case of administrative / disciplinary or academic decision by the College, I will not refer them to any Court of Law, under any circumstances.
- b. I also understand that, in case my son is granted provisional admission in class _____, I shall also give undertaking that if my son could not obtain marks spelt out in the admission criteria or fails in any subject in First Term Examination, his admission can be cancelled, without any intimation.
- c. In case my son fails, continuously in the Terminal Exams or if he could not obtain 60% marks or fails in any subject in the send-up exam and or is unable to achieve 75% attendance (as per laid down academic hours), his admission to Federal Board will not be processed as a regular candidate and he may be withdrawn from this College. I will not be having any right to challenge this decision in any court of law.
- d. I take full responsibility regarding my son / ward traveling accompanied / un-accompanied to and from Army Burn Hall College for Boys, Abbottabad, during vacation, weekends, leave, etc, as long as he is a student of the College.
- e. I will not request for the change of status of my son / ward from boarder to day scholar after Admission in Army Burn Hall College for Boys, Abbottabad.
- f. I undertake that my son/ward will do nothing in or outside the College premises in contravention of the College discipline, and he will follow the decisions of the Principal/the College council, which I understand will be binding on my son and me.
- g. In case my son/ward is found guilty of in discipline, defamation, disrespect to the teaching faculty, or of any subversive activity/violation of any of the laid down College Rules, he will be withdrawn without any prior notice and that I or my son/ward shall have no right to challenge the decision at any forum.
- h. I pledge that in case of any medical issue observed after admission, which may render my son unfit for the boarding environment of the College, he will be liable to be expulsion without any prior notice.

- a. A student failing in two subjects will be considered FAILED as a whole, irrespective of his aggregate %age.
- b. A student failing in one subject with aggregate %age less than 50% (Prep to 2nd Year Class) and less than 60% (Pre-JC and A2 Level) respectively will also be considered FAILED.
- c. **A student failing in any above (1) or (2) will have to repeat the same class.**
- d. Repeater of one class will be expelled, in case he fails again.
- e. Consecutive failure in Terminal exams and/or Final Exams/Send-up will repeat the class or may be expelled.
